Important: Registration and participation are subject to the Terms & Conditions and Waiver below.

1. Event Organizer

Coorg Infinity Run 2027 ("Event") is organized by Idovent Private Limited ("Idovent", "Organizer", "we", "us", or "our"). By registering for or participating in the Event, you agree to these Terms & Conditions and the Participant Waiver & Release contained in this document.

2. Registration

Registration is personal to the participant and is subject to successful completion of registration and payment. Participants must provide accurate, complete, and current information. The Organizer may reject, cancel, or suspend a registration where information is inaccurate, fraudulent, duplicated, or otherwise invalid.

3. Eligibility

Participants must satisfy the age and category-specific eligibility requirements published on the official registration page. Where a category requires previous race participation or a qualifying timing, the participant must provide genuine and verifiable information when requested.

- Participants must comply with all stated age requirements.
- Any qualifying race/timing requirement must be met before the applicable registration deadline.
- The Organizer may request proof of eligibility and may refuse participation where eligibility cannot be established.

4. Participant Health and Fitness

Running is a physically demanding activity. Participants are responsible for determining whether they are medically and physically fit to participate and should consult an appropriate medical professional where necessary.

5. Registration Fees and Payments

All registration fees are displayed in Indian Rupees unless otherwise stated. Registration is considered confirmed only after successful payment and issuance of a valid booking/registration confirmation. The Organizer is not responsible for delays or failures caused by banks, payment gateways, internet connectivity, or other third-party systems.

6. Refunds, Cancellations and Transfers

Registration fees are generally non-refundable unless the Organizer expressly announces otherwise. Any refund, cancellation, transfer, category-change, or deferral facility will be subject to the rules and deadlines communicated by the Organizer. Third-party payment or convenience charges may be non-refundable where applicable.

7. Event Changes and Cancellation

The Organizer reserves the right to modify the Event date, venue, route, race categories, start times, procedures, facilities, or other arrangements where reasonably necessary, including due to weather, government directions, public safety, force majeure, natural disasters, operational constraints, or circumstances beyond the Organizer's reasonable control.

8. Bibs and Race Kits

Bibs and race kits will be distributed according to the collection schedule and identification requirements communicated by the Organizer. Participants must use only their assigned bib. Bib swapping, transfer, duplication, alteration, or unauthorized use is prohibited.

9. Race Rules and Disqualification

Participants must follow instructions issued by race officials, volunteers, medical personnel, traffic authorities, and event staff. The Organizer may disqualify or remove a participant for unsafe conduct, cheating, unauthorized course deviation, bib misuse, providing false information, or violation of Event rules.

- Do not obstruct other participants.
- Do not use another participant's bib.
- Do not intentionally shorten or alter the course.
- Follow all traffic, route, safety, and marshal instructions.

10. Timing and Results

Where timing is provided, results are subject to the timing system and verification procedures. Timing data may be corrected or withdrawn in cases of technical error, rule violation, course irregularity, or suspected manipulation.

11. Medical and Emergency Assistance

Medical and emergency support may be available at the Event. Participants authorize Event medical personnel and emergency responders to provide reasonable assistance where considered necessary. Participants understand that emergency response may involve inherent delays or limitations.

12. Personal Belongings

Participants are responsible for their personal belongings. The Organizer is not responsible for loss, theft, damage, or misplacement of personal property except to the extent liability cannot lawfully be excluded.

13. Photography, Video and Publicity

The Event may be photographed, filmed, livestreamed, or otherwise recorded. By participating, you acknowledge that your image, voice, name, race information, or likeness may appear in Event documentation and promotional materials, subject to applicable law and the Organizer's Privacy Policy.

14. Sponsors and Third-Party Services

The Event may involve sponsors, vendors, payment providers, accommodation providers, transportation providers, timing companies, and other third parties. Their services may be subject to separate terms and policies. The Organizer is not responsible for third-party services except to the extent required by applicable law.

15. Code of Conduct

Participants must behave respectfully toward other participants, staff, volunteers, officials, local residents, and the public. Harassment, violence, abusive behavior, discrimination, intoxication-related misconduct, or conduct creating a safety risk may result in removal from the Event without refund.

16. Privacy

Personal information will be collected and processed in accordance with the Coorg Infinity Run 2027 Privacy Policy and applicable law.

17. Limitation of Liability

To the maximum extent permitted by applicable law, the Organizer and its officers, employees, volunteers, contractors, and event partners will not be liable for indirect, incidental, special, or consequential loss arising from participation in or

attendance at the Event, except where such liability cannot lawfully be excluded.

18. Indemnity

To the extent permitted by applicable law, a participant agrees to be responsible for losses, claims, damages, or expenses arising from the participant's intentional misconduct, fraud, material breach of these Terms, or unlawful acts.

19. Governing Law

These Terms & Conditions and Waiver shall be governed by the laws of India. Any dispute shall be subject to the jurisdiction of courts having appropriate jurisdiction, subject to applicable law.

PARTICIPANT WAIVER & RELEASE

The following provisions form an integral part of the Event Terms & Conditions.

20. Acknowledgement of Risk

I understand that participation in Coorg Infinity Run 2027 involves physical activity and inherent risks. These may include falls, collisions, traffic or road hazards, uneven surfaces, weather conditions, dehydration, heat or cold exposure, fatigue, illness, injury, disability, or, in rare circumstances, death.

21. Voluntary Participation

I am voluntarily participating in the Event and accept the inherent risks associated with participation. I understand that I am responsible for deciding whether to start, continue, or stop during the Event based on my condition and circumstances.

22. Fitness and Medical Condition

I confirm that, to the best of my knowledge, I am physically capable of participating in the selected race category. I will disclose relevant information to medical personnel when necessary and will not participate if I believe doing so would create an unreasonable risk to myself or others.

23. Compliance with Instructions

I agree to follow the instructions of race officials, medical personnel, volunteers, traffic authorities, and other authorized Event personnel. Failure to follow instructions may result in disqualification or removal.

24. Medical Treatment and Emergency Care

In the event of an accident, injury, illness, or medical emergency, I authorize reasonable first aid, medical assessment, emergency transportation, or other treatment considered necessary by qualified medical or emergency personnel, subject to applicable law and medical protocols. I understand that the Organizer does not guarantee any particular medical outcome.

25. Release and Waiver

To the maximum extent permitted by applicable law, I release and hold harmless Idovent Private Limited and its directors, officers, employees, volunteers, contractors, officials, sponsors, venue owners, service providers, and authorized event partners from claims arising from my participation in the Event to the extent such claims result from inherent risks of participation or my own acts or omissions.

26. Exceptions to Release

Nothing in this Waiver is intended to exclude or limit liability that cannot legally be excluded or limited under applicable law, including liability arising from fraud or other liability where exclusion is prohibited by law.

27. Personal Responsibility

I accept responsibility for my personal safety, equipment, hydration, nutrition, and conduct during the Event. I understand that weather and course conditions may change and that I must act responsibly in response to those

conditions.

28. Emergency Contact

I confirm that the emergency contact information provided during registration is accurate and that I have authority to provide it for Event safety and emergency purposes.

29. Photography and Recording

I acknowledge that photography, videography, audio recording, and livestreaming may take place during the Event. I understand that my image or likeness may be captured as part of the Event and used for documentation, publicity, marketing, social media, and future Event promotion, subject to applicable law and the Privacy Policy.

30. Participant Declaration

By registering for and/or participating in the Event, I confirm that I have read and understood these Terms & Conditions and Waiver, understand the risks involved, and voluntarily accept the terms stated herein. If I am registering or participating as a minor, I confirm that the required parent/legal guardian authorization has been obtained.

31. Electronic Acceptance

I agree that checking an acceptance box, submitting registration, making payment, signing electronically, or otherwise completing the registration process may constitute my electronic acceptance of these Terms & Conditions and Waiver to the extent permitted by applicable law.
